- 1. Title: Healing Touch Certification Standards for a Healing Touch Certified Practitioner (HTCP) Renewal
- 2. Purpose: The purpose of this document is to define the standards to renew certification as a Healing Touch Certified Practitioner (HTCP)

3. Definitions:

3.1. Healing Touch Certified Practitioner (HTCP) Board Certification is acknowledgement of individuals who successfully meet the required standards for Healing Touch Practitioner Certification

3.2. Active and In Good Standing

The terms "active and in good standing" means that the applicant is approved to practice as a Healing Touch Certified Practitioner and their certification is current, up to date, and has not been challenged or compromised by unprofessional or unethical behavior. A Practitioner whose certification has been suspended or revoked, or who has permitted their certification to lapse into an inactive status is not "active and in good standing".

- 4. Scope: This document covers policies and procedures for renewing certification as a HTCP.
- 5. Eligibility: Renewal as a Healing Touch Certified Practitioner (HTCP) is open to current HTCP's beginning 90 days prior to expiration of their current certification. Applicants must be active and in good standing.

Renewal of the HTCP certification credential occurs every five years. This process requires submission of a Healing Touch Certified Practitioner Renewal Application at least 30 days prior to the current certification expiration date.

Instructions for certification renewal applications are found in the certification packet form HTC-934

- **6. Certification Lapse Policy:** In the event that certification is allowed to lapse the following events will take place.
 - **6.1.** Public notice of expired certification will be made through Practitioner's status as listed on the practitioner directory. Certification status will display the certification expiration date
 - **6.2.** The Credential Healing Touch Certified Practitioner or the acronym HTCP may no longer be used after the expired practitioner's name.
 - **6.3.** Guidelines for reinstatement: If HTCP has certification lapsed process for renewal:
 - 6.3.1. Within two years past the Certification expiration date submit a renewal packet. All information must be completed and continuation education hours must be current within the previous 6 year period.
 - 6.3.2. After two years past the Certification expiration date. It is required to provide a current case study and a letter of recommendation from a QM in addition to the competition of the renewal packet.
- 7. Standards of Certification Renewal: Renewal is an action representing continued support of the credentialed Healing Touch Certified Practitioner (HTCP) through ongoing self-development and continuing education to stay current in the field.

7.1. Evidence of Participation

- 7.1.1. Active participation keeps the Practitioner well informed of current education updates, provides self-growth and discovery and involvement in the Healing Touch Community. The practitioner honors the credential by ongoing participation and involvement with Healing Touch and the Healing Touch community. Actions, which demonstrate this involvement, include; Healing Touch classes, related continuing education offerings, attending Healing Touch conferences, and networking with Healing Touch and other holistic practitioners. Be as creative as possible to honor the diversity within the world of energy therapies/holistic healthcare and Healing Touch local, regional or global activities.
- 7.1.2. **Requirement:** The HTCP recertification requirement is to demonstrate enhanced competence through completion of 75 hours of continuing education and participation every five (5) years.
 - 7.1.2.1. Note the following category requirements may overlap and are not additive:
 - 7.1.2.1.1. At least 20 of the total 75 hours must be in Healing Touch Program related education.
 - 7.1.2.1.2. At least 37.5 of the total 75 hours must be in energy medicine. The remainder of the hours should be in professional development and/or self care.
 - 7.1.2.2. Of the total 75 hours required, 37.5 hours must be recognized as official CE hours from which you receive a certificate from a recognized Provider of continuing education. These official hours can be obtained for any category Healing Touch, Energy Medicine and/or Practitioner Development and Self Care. Copies of your certificates are not required with your packet, but must be provided if requested later.

7.1.3. Submission Guidelines:

- 7.1.3.1. Complete the Certification Renewal Continuing Education Hour Worksheet (HTP-964)
- 7.1.3.2. Include a single-spaced half to one page overall summary of your experiences in self and professional growth as related to the above continuing

education hours. Please address the following information in each area of exploration:

- 7.1.3.2.1. How has this information moved you forward in your growth?
- 7.1.3.2.2. What linkages from your resources have you made with your HT practice?
- 7.1.3.2.3. How can you use this information to assist and educate your clients?

7.2. Practice Development

- 7.2.1. Submission Guidelines: Please write a one page, single spaced summary on your growth in your HT practice. Include reflection on these questions and your specific plans.
 - 7.2.1.1. How has your practice grown or changed and what have you learned?
 - 7.2.1.2. How have you shared your learning?(How have you been involved the Healing Touch community?)
 - 7.2.1.3. What are your plans for future growth: personal, practice and community involvement?

7.3. Assertion of Personal Responsibility

- 7.3.1.1. **Submission Guidelines:** Please sign and submit the Practitioner Certification Renewal Assertion of Personal Responsibility (HTP-934-B)
- **7.4.** Healing Touch Certified Practitioner Entry Level Proficiency Exam Any HTCP who was certified prior to the adoption of the Healing Touch Certified Practitioner Entry Level Proficiency Exam requirement must achieve a passing score on the exam prior to submitting their application for recertification at their next regular recertification interval. The HTCP is only required to pass the exam once.

7.6. Applicant Grievance Procedure

An applicant who has a grievance may write to the Certification Administrator who will direct the grievance to the HTCGC Chairperson or Vice Chairperson. Grievances need to be filed within 45 days of notification of Application Packet outcome. The Chair and Vice Chair will work with the specific packet reviewers to address the grievance. The Chairperson will notify the applicant of the final grievance review outcome. Decisions are final. The exam outcome is based upon an applicant achieving a passing score. It may be retaken up to a total of three times.
